

Ministerial Order No. 2018-21

WHEREAS, pursuant to section 7 of the Schedule of the Assured Income for the Severely Handicapped Act (the Act), the Minister may determine the amount of a personal benefit and the frequency with which a personal benefit may be provided for the purposes of Schedule 3 of the Assured Income for the Severely Handicapped General Regulation (the Regulation);

AND WHEREAS An Act to Combat Poverty and Fight for Albertans with Disabilities provides for the annual adjustment of benefit amounts by the Alberta Consumer Price Index in accordance with the Act and Regulations;

I, IRFAN SABIR, Minister of Community and Social Services, effective January 1, 2019, pursuant to section 7 of the Schedule of the *Act*, establish the amounts of personal benefits and the frequencies with which personal benefits may be provided for the purposes of calculating benefit amounts under Schedule 3 of the Regulation, as set out in the attached Appendix.
