
MINISTERIAL ORDER NO. 307/2016

Delegated Functions and Corresponding Sections of the *Income and Employment Supports Act* (IESA) and its Regulations

1. Extend time for appeal – Income and Employment Supports Act, section 45(2)

2. Determine whether to disclose personal information – *Income and Employment Supports Act*, section 49(2)(c)

3. Determine when a person may be designated as an adult person – Income Support, Training and Health Benefits Regulation, section 1(1)(b)(ii)(C)

4. Determine what savings programs could be an exempt asset for the purposes of determining eligibility for benefits – Income Support, Training and Health Benefits Regulation, Schedule 1, section 1(1)(h) and Schedule 1, section 2(1)(i)

Director appointed under s. 3 of IESA by the Minister of Advanced Education

5. Set the amount of the income remittance on behalf of an apprentice or employment insurance learner regarding assistance received Part 2 of the Act – Income Support, Training and Health Benefits Regulation, Schedule 4, section 24

Director appointed under s. 3 of IESA by the Minister of Advanced Education

6. Determine cost for the special diets – Income Support, Training and Health Benefits Regulation, Schedule 4, sections 1 and 21

Director appointed under s. 3 of IESA by the Minister of Advanced Education

7. Set maximum rates for private child care – Income Support, Training and Health Benefits Regulation, Schedule 4, sections 1 and 16(1)(b)

Director appointed under s. 3 of IESA by the Minister of Advanced Education
Director, Common Service Delivery, Human Services

8. Provide additional supplementary payments or allowances - Income Support, Training and Health Benefits Regulation, Schedule 4, sections 1 and 28

9. **Provide medical or surgical items – Income Support, Training and Health Benefits Regulation, Schedule 4, section 1 and 27**
